

State-by-state general disclosures are required by 34 CFR 668.43(5)(v) for academic programs designed to meet educational requirements for a specific professional license or certification that is required for employment in an occupation, or is advertised as meeting such requirements. These disclosures refer only to educational requirements, and there may be other requirements, in addition to education, that must be met in order to qualify for licensure (e.g. sit for an exam, years of work experience, etc.)
